- 2. First Aid child care staff members scheduled did not have verification of completion of First Aid
- 3. First Aid trained child care staff member was not present in each building used by the program.
- 4. CPR child care staff members scheduled had expired training
- 5. CPR child care staff scheduled did not have verification of completion of CPR
- 6. CPR trained child care staff member was not present in each building used by children
- 7. CPR training taken by staff was not appropriate for all ages and developmental levels of the children in care
- 8. CPR audiovisual or electronic media training taken by staff did not include an in-person component of the training
- 9. Communicable Disease child care staff members scheduled had expired training

- 12. Child Abuse child care staff members scheduled had expired training

- 13. Child Abuse child care staff scheduled had not taken Child Abuse training
- 14. Child Abuse trained child care staff was not in each building used by the program

- 5. The first aid training was expired.
- 6. The CPR training was expired.
