Complaint Allegations

If a program disagrees with a licensing finding, the program may request a review of the finding(s). Code: The program staff is required to supervise children in their assigned group by sight and hearing. Supervision includes being near enough to respond and reach children immediately including responding to the child's basic needs and protecting them from harm.

Allegation: Children are not properly supervised as required by the rule.

Determination: Substantiated

Findings: During the inspection, it was determined that children were not being properly supervised in that a group of children were within hearing of a child care staff member, however, the children were not within sight at all times. Children must be supervised according to rule and within both sight and hearing of a child care staff member at all times. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
