2. Staff member(s) did not follow emergency exiting procedures;

3. Staff member(s) allowed child(ren) to do something unsafe;

4. Staff member did something unsafe when the staff member left their backpack unattended and a student gained access to the keys that contained pepper spray and accidentally discharged the spray.5. Other [].
