Finding: During the inspection, it was determined that the program provided false information, in that the Administrator documented in the Ohio Professional Registry and stated during the Verification Visit that certain Staff Members were Lead Teachers in the Infant and Toddler Classrooms. According to information obtained while at the center, the Lead Teachers were not in the classrooms and did not fulfill the role as required. The rule requires the program to provide accurate and truthful information to the Department. Submit the program’s corrective action plan to the Department to verify compliance with the requirements of this rule.
