Finding: In review of the employee records, it was determined that the contracted driver used to transport children did not have a current and complete copy of the JFS 01266 "Contracted Driver Qualification Statement for Child Care" on file at the program. 2. The training expired, as it is only valid for two years;
3. Not all administrators, Child Care Staff Members, and substitutes have completed the training.

9. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
