Allegation: Due to being short-staffed, the center has been over ratio.

Determination: Substantiated

Findings: During the inspection, required staff/child ratios were not maintained for [the same group/different groups] on multiple occasions, as noted below:

The ratio determined for the infant group was 1 Child Care Staff Member(s) for 9 children. Additionally, a ratio of 1 Child Care Staff Member(s) for 26 children was determined for the preschool and pre k group.

Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

Findings: During the inspection, group size limitations were not maintained for the group of preschool and pre k, as it was determined there were 26 children grouped together. The group size shall not exceed twice the maximum number of children allowed per Child Care Staff Member.
