Findings: During the inspection, a bug pesticide was found in the daycare room. There were also cleaning supplies in the closet by the front door. Please get a child proof lock for both closets or move the supplies out of reach. You are also able to put all supplies and chemicals into one closet and then lock it.

Provide staff training. Submit the program's corrective action plan, which includes a statement that the potentially hazardous substance is no longer accessible to children and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
