Findings: In review of the staff records, it was determined that Amir's background check JFS 1176 was not on file. He needs to get his FBI check redone and submit a new a background request in the OPR (OCCRA).

Submit the program's corrective action plan, which includes a copy of the JFS 01176, or a copy of the preliminary approval or a statement that the individual(s) are no longer engaged in assigned duties and are not near children until the preliminary approval has been received, to the Department to verify compliance with the requirements of this rule.
