Allegation: Program is out of ratio in multiple groups.

Determination: Substantiated

Findings: During the inspection, required staff/child ratios were not maintained for different groups on multiple occasions, as noted below:

The ratio determined for the PK group was 1 Child Care Staff Member(s) for 17, 20 and 22 children. Additionally, a ratio of 1 Child Care Staff Member(s) for 18 children was determined for the morning mixed age 3-5 year old group, 1 staff member to 10 children in the toddler room, Cardinals room 1 staff member to 18 children.

Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

Findings: During the inspection, group size limitations were not maintained for the group of infants as it was determined there were 13 children grouped together. The group size shall not exceed twice the maximum number of children allowed per Child Care Staff Member.
