Finding: During the inspection, it was determined that at least one piece of equipment, furnishings, or material at the program was not constructed of materials to facilitate cleaning as noted in number(s) 6 below: 1. The material had a tear. 2. The material was not washable. 3. The material was porous. 4. The surface was cracked. 5. The surface was repaired, but in a manner that still did not facilitate cleaning. 6. Other, the cover for the infant changing table was cloth and could not be sanitized between diaper changing. Equipment, furnishings, and furniture shall be constructed of materials to facilitate cleaning. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. Finding: During the inspection, it was determined that the following information was not posted for item number(s) 1 below: 1. Fire alert plan, including a diagram indicating evacuation routes was not posted in the room the infants were being served. 2. Weather alert plan was missing details for []. 3. Pretend or dramatic play materials 7. Music equipment 8. Transportation materials and equipment 9. Gross motor equipment 10. Sensory motor equipment 11. School age children were not provided sufficient equipment and materials in at least five of the first nine categories above.
