- 2. Staff member(s) allow child(ren) to do something unsafe;
- 3. Staff member(s) doing something unsafe;
- 4. Other: Allowing a parent to apply guidance and management techniques.

While the program did not protect the child(ren) from an unsafe situation and/or person, it was determined the situation would not or did not result in a serious incident or injury to a child. All program employees must take actions to protect children in care. Provide staff training.
