Code: The program is required to store chemicals and machinery in a place that is inaccessible to children. The program is required to provide an outdoor play area away from machinery in operation.

Finding: During the inspection, a potentially hazardous item or toxic substance, a cleaning agent (2) was stored in an unlocked cabinet under the bathroom sink in the staff restroom that opens into the in the preschool room and a bottle of bleach and water mixture (1) was on the top of a low shelf n the preschool room where children had access to it, as noted.

1. Bleach.
2. Cleaning agent.

Provide staff training. Submit the program's corrective action plan, which includes a statement that the potentially hazardous substance or item is no longer accessible to children and/or children will not be outside when machinery is in use and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
