Complaint Allegations

If a program disagrees with a licensing finding, the program may request a review of the finding(s). In addition, if the program is star rated, the rating may be impacted if a serious or moderate risk non-compliance is cited.

Code: The program staff is required to hold infants or have the infant sitting up while feeding. The program staff may not place an infant in a crib with a bottle.

Allegation: Staff are not holding infants during feedings. They prop bottles on a boppy pillow.

Determination: Substantiated

Findings: During the inspection, it was determined that the program did not meet the requirements for bottle feeding as noted in number 3 below:

1. A bottle was propped for an infant feeding.
2. An infant was placed in a crib with a bottle.
3. An infant was not held or fed sitting up for bottle feedings.

Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
