The ratio determined for the Infant group was 1 Child Care Staff Member(s) for 6-7 children. Additionally, a ratio of 1 Child Care Staff Member(s) for 22-24 children was determined for the PS group.

Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training. Submit the program’s corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
