Complaint Allegations

Code: The program staff is required to follow the practices preferred by the parents.

Allegation: It was alleged that the infant feeding practices used by the childcare staff member were not in accordance with parental preferences.

Determination: Substantiated

Findings: During the inspection, it was determined that the feeding practices used by child care staff members were not in accordance with parental preferences, in that the infant was fed only one bottle that contained formula in a seven-hour day. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is required at this time.
