Rule: 5180:2-12-25 Medication Administration  
Code: The program staff is required to administer medication to the identified child on the documentation.

Finding: It was reported by the program that a child was given a second dose of medication when the medication was administered by two different staff. This required the child go the hospital for care. Provide training to staff designated to administer medication, to ensure the medication policies are followed and medications are administered as prescribed. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule along with a copy of the letter notifying parents of the serious risk not compliance assessed.

Rule 5180:2-12-03 requires the program to notify parents when a serious risk non-compliance is cited. The notification must inform parents of the serious risk non-compliance and include the Department of Children and Youth website and location of further information regarding the determination. Submit the program's corrective action plan, which includes a statement that training was provided and a copy of the written parent notification, to the Department to verify compliance with the requirements of this rule.
