Rule: 5101:2-12-03 Inspection Requirements

<u>Code</u>: The program staff is required to provide true and accurate information.

<u>Finding</u>: During the inspection, it was determined that the program provided false information, in that a child care staff member had provided the administrator with a falsified medical statement. The rule requires the program to provide accurate and truthful information to the Department. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

Domain: 04 Indoor/Outdoor Space

<u>Rule</u>: 5101:2-12-11 Outdoor Space Requirements <u>Code</u>: The program is required to have an outdoor play space free from immediate risk.

<u>Finding</u>: During the inspection, it was determined that an area was used which was not protected from traffic and other hazards by a fence in good repair, or other barrier. Although the fence or natural barrier was not meeting the rule requirements, it was determined to not present an immediate risk for a child to be able to leave the playground. The fence or gate was not in good repair and/or being used inappropriately as noted in number(s) 2 and 3 below:

- 1. The fencing had missing slat boards.
- 2. The fencing was broken (one slat board cracked across the board).
- 3. The fencing was loose (one slat board not secured at the bottom).
- 4. The fencing was rotting.
- 5. The gate was broken and did not close.
- 6. The gate was locked.
- 7. The latch on the gate was broken.
- 8. The latch was easily opened by children on the playground.
- 9. The gate had no latch.



Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance.
