Rule: 5101:2-12-13 Handwashing Requirements

Code: The program is required to have all staff and children wash their hands as outlined in rule.

<u>Finding</u>: During the inspection, it was determined that handwashing requirements were not followed as listed in number(s) 2,3,5, & 12 below, as required in rule.

- 1. At least one staff/child did not wash their hands upon arrival for the day.

- 11. At least one staff did not wash their hands before eating, serving or preparing food or bottles or feeding a child.

- 14. At least one child did not wash their hands after water activities.

<u>Finding</u>: In review of the staff records, it was determined that at least one child care staff member had not completed required health and safety training as noted in number(s)4,5 & 6 below:
