Finding: During the inspection, it was determined that the program's procedure for brushing teeth was not sanitary, as noted in number 3 below, as required. 1. The toothbrushes were not labeled. 2. The toothbrushes were not stored with bristles to air dry in a manner to prevent contact with other toothbrushes or surfaces. 3. The toothpaste from a common tube was not dispensed on individual clean pieces of paper or a paper product for each child. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is not required at this time.
