Findings: During the inspection, it was determined that the program provided false information, in that a childcare staff member did not have a valid high school diploma. The rule requires the program to provide accurate and truthful information to the Department. Submit the program's corrective action plan, which includes a statement that any staff that do not meet the education requirements are no longer employed as a childcare staff member at the program, to the Department to verify compliance with the requirements of this rule.

Code: The program is required to place infants in cribs while sleeping.

Findings: During the inspection, it was determined that the equipment in number 6 below had been used for sleeping infants and did not allow the infant to sleep on a firm mattress:

1. Mesh cribs;
2. Play pens;
3. Bassinets;
4. Cots;
5. Car seats;
6. Infant swings;
7. The floor;
8. Infant seats;
9. An infant placed in a car seat in a crib;
10. Other [].

Infants must be provided with a crib, which meets requirements specified in this rule, for resting and sleeping. Provide staff training. Submit the program's corrective action plan, which includes a statement that staff training was provided, to the Department to verify compliance with the requirements of this rule.
