Rule: 5101:2-12-12 Safe Environment

<u>Code</u>: The program is required to store chemicals and machinery in a place that is inaccessible to children. The program is required to provide an outdoor play area away from machinery in operation.

<u>Finding</u>: During the inspection, a potentially hazardous item or toxic substance was stored where children had access to it, as noted in numbers 1 and 2 below.

- 1. Bleach. (Unlocked door in toddler room)
- 2. Cleaning agent. (Under kitchen area sink. The door was open)
- 3. Fish tank chemicals.
- 4. Gasoline.
- 5. Pesticide.
- 6. Poison, including insect/rodent poison.
- 7. Flammable substance.

- 8. Windshield washer fluid.
- 9. Aerosol cans.
- 10. A lawn mower.

Provide staff training. <u>Code</u>: The program is required to provide equipment that is safe and hazard free.

<u>Finding</u>: During the inspection, equipment was determined to be unsafe or hazardous to children and in need of repair as noted in numbers 1 and 4 below:

- 1. The equipment had sharp points or corners; (Broken toy bins (sensory, train and dramatic play)- Preschool)
- 2. The equipment had splinters;
- 3. The equipment had protruding nails;
- 4. The equipment had loose or rusty parts; (Xylophone- Toddler)
- 5. The equipment had paint which contains lead or other poisonous materials;
