Finding: In review of 25% of the children's records, it was determined that completed medical statements were not on file, as required, for children listed on the JFS Children's Record Review For Child Care as indicated in number(s) 2 and 8 below:

3. Medical(s) were missing child's name and date of birth
4. Medical(s) were missing the date of the medical examination
