Rule: 5101:2-12-12 Safe Environment

Code: The program is required to store chemicals and machinery in a place that is inaccessible to children. The program is required to provide an outdoor play area away from machinery in operation.



Finding: During the inspection, a potentially hazardous item or toxic substance was used or stored in the Gym where children had access to it, as noted in number 2 below.

1. Bleach.
2. Cleaning agent (Swiffer-style mop in the Gym with cleaning solution attached was next to the cabinet accessible to preschool children playing in the gym).
3. Fish tank chemicals.
4. Gasoline.
5. Pesticide.
6. Poison, including insect/rodent poison.
7. Flammable substance.
8. Windshield washer fluid.
9. Aerosol cans.
10. A lawn mower.
11. A weed trimmer.
12. Hedge trimmers.

Provide staff training. 1. Fire alert plan, including a diagram indicating evacuation routes (fire alert plan was not posted)
2. Weather alert plan was missing details for [].

3. Cardiopulmonary resuscitation (CPR) training was not completed within ninety days of hire.
4. The child abuse and neglect recognition and prevention training was expired.
5. The first aid training was expired.
6. The CPR training was expired.
