1. The material had a tear/was worn through (vinyl soft climber in infant 2, red vinyl chair in PreK 1).
2. The material was not washable.
3. The material was porous.
4. The surface was cracked.
5. The surface was repaired, but in a manner that still did not facilitate cleaning (tape on red vinyl couch in Infant 2, and on blue vinyl couch in PreK 2).
