Rule: 5101:2-12-12 Safe Equipment

<u>Finding</u>: During the inspection, it was determined that indoor swings, slides, climbers, and climbing apparatus (climbers in infant/toddler classrooms 43 and 42) did not have required shock absorbent protective covering under and around the equipment as noted in number(s) 1 below:

- 1. A shock absorbent protective covering was not used.
- 2. The mats were not at least one and one-half inches thick for equipment over three feet high.
- 3. The mats were not used according to the manufacturer's guidelines.
