Rule: 5101:2-12-25 Medication Administration

Finding: During the inspection, it was determined that a medication, inhaler, was within the reach of children in the preschool room in that the medication was in the transportation backpack near the floor in the classroom. All medications must be stored out of the reach of children. Create procedures that assure medications will always be inaccessible to children. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

6. The CPR training was expired.
