**Finding:** During the inspection, it was determined that the equipment in number(s) 8 below had been used for sleeping infants and did not allow the infant to sleep on a firm mattress:

9. An infant placed in a car seat in a crib;

Infants must be provided with a crib, which meets requirements specified in this rule, for resting and sleeping. Provide staff training. During the inspection, it was determined that at least one area of the program or at least one piece of equipment had chipping or peeling paint. 10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
