**Rule:** 5101:2-12-25 Medication Administration

**Finding:** During the inspection, it was determined that a medication, Epipen was within the reach of children in the the C room. All medications must be stored out of the reach of children. Create procedures that assure medications will always be inaccessible to children. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

The program must have safety covers on all electrical outlets, including power strips and surge protectors, which are within the reach of the children. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. **Finding:** During the inspection, it was determined that at least one child in the preschool group did not wash his or her hands at the time listed in number(s) 3 below, as required in rule.

3. After toileting/diaper change. (Trash can blocking sink in restroom.)

9. When visibly soiled (must use soap and water)
