Rule: 5180:2-12-20 Cribs

Code: The program staff is required to place infants on their back to sleep unless an alternate method is indicated on a completed JFS 01235 "Sleep Position Waiver for Child Care".

Finding: During the inspection, it was determined that infants younger than twelve months old were placed in a position other than on their backs to sleep. It was determined that although the center had on file written instructions signed by the child's physician which documents written permission for an alternative sleep method, the current version of the prescribed JFS 01235 "Sleep Position Waiver for Child Care" form was not on file, as required by this rule. Submit the program's corrective action plan, which includes a copy of the prescribed form signed by both the child's physician and the parent, and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
