Findings: During the inspection, it was determined that the outdoor play space was not free of trash or foreign objects or general hazards as noted in number 15 below:

1. The outdoor area was littered with trash.
2. The trash can was missing a lid.
3. The trash can was not emptied from the day(s) before.
4. The trash can was overflowing with trash.
5. The trash can was infested with insects.
6. The trash can was visibly dirty.
7. There was broken glass.
8. There were tall weeds.
9. There was poison ivy.
10. There were tree branches.
11. There was mold visible.
12. There were thistles with prickles.
13. There were bird droppings.
14. The sandbox was contaminated.
15. Other: The fencing on the gate, which was not indicated in the complaint investigation, was observed to have come apart from the gate's frame causing a potential injury hazard.
