Rule: 5101:2-12-12 Safe Equipment

<u>Code</u>: The program is required to refrain from placing indoor swings, slides, climbers, and climbing apparatus directly over a hard surface. Shock absorbent protective covering, intended to be a fall surface per manufacturer's guidelines, shall be placed and used under the equipment.

<u>Finding</u>: During the inspection, it was determined that indoor swings, slides, climbers, and climbing apparatus did not have required shock absorbent protective covering under and around the equipment in Giraffes, Cubs and Kangaroos, as noted in number 1 below:

1. A shock absorbent protective covering was not used.

- 2. The mats were not at least one and one-half inches thick for equipment over three feet high.
- 3. The mats were not used according to the manufacturer's guidelines.

Fire alert plan, including a diagram indicating evacuation routes (written fire alert plan was missing).
Weather alert plan was missing details for: severe thunderstorms, tornadoes, flash flooding, major snowfall, blizzards, ice storms or earthquakes.



3. Weather alert plan was missing a diagram indicating evacuation routes.

5. The substitute(s) had been used more than ninety days annually between July first and June thirtieth and had not completed at least six hours of professional development
