Rule: 5101:2-12-12 Safe Environment

<u>Code</u>: The program is required to store chemicals and cleaning and sanitizing supplies in a place that is inaccessible to children. - 15. Other: unopened, solid air freshener labeled keep out of reach of children was in the restroom under the sink in a cupboard.
