The ratio determined for the combined (infant, toddler, preschool, and school age) group was 1 Child Care Staff Member(s) for 12 children (youngest being 9 months old). Additionally, a ratio of 2 Child Care Staff Members for 16 children (youngest being 9 months old) was determined for the combined group.

Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
