<u>Finding</u>: During the inspection, required staff/child ratios were not maintained for different groups on multiple occasions, as noted below:

The ratio determined for the preschool/school age group which contained 3 year olds was 1 Child Care Staff Member(s) for 24 children. Additionally, a ratio of 1 Child Care Staff Member(s) for 6 children was determined for the infant group which contained children under 12 months and a ratio of 1 staff member for 19 children was determined for the school age group.

Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
