A walking surface that is not hazardous to children must be maintained at the program. Finding: During the inspection, it was determined that a surge protector in the young toddler room did not have childproof receptacle covers. The program must have safety covers on all electrical outlets, including power



strips and surge protectors, which are within the reach of the children. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is not required at this time.
