14. Other potentially hazardous substance, equipment or machinery: Tool box needs locked, sharp tools, equipment behind garage needs to be moved and inaccessible to children.

Provide staff training. Submit the program's corrective action plan, which includes a statement that the potentially hazardous substance or item is no longer accessible to children and/or children will not be outside when machinery is in use and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
