Findings: During the inspection, required staff/child ratios were not maintained for different groups on multiple occasions, as noted below:

The ratio determined for the Beetle Bug group was 1 Child Care Staff Member(s) for 6 children, the youngest child being under 1 year old. Additionally, a ratio of 1 Child Care Staff Member(s) for 20 children was determined for the Lightning Bug group (preschool children)



Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
