Finding: During the inspection, it was determined that an outlet in Classroom B did not have childproof receptacle covers. The program must have safety covers on all electrical outlets, including power strips and surge protectors, which are within the reach of the children. Finding: During the inspection, it was determined that outdoor play equipment was unsafe as noted in numbers 3 and 11 below:

2. There was protruding bolts;
3. There were cracks on Toddler slide and preschool alligator.

5. There was splintering wood;
