**Domain: 02 Safe & Sanitary Environment**

Rule: 5101:2-13-13 Smoke Free

Findings: During the inspection, it was determined that smoking had occurred in the program building or vehicle during hours the program was not in operation; however, one parent had not been given written notice of this. Correct the violation and submit the program's corrective action plan to verify compliance with the requirements of this rule.

Rule: 5101:2-13-12 Pets

1. The menu was not posted. Only one day for the current week was posted.
2. The posted menu was not in a visible place readily accessible to parents.
3. The menu was not currently dated.
4. The entire menu was substituted.
5. At least one item on menu did not match what was served.
6. The meal or snack served did not match the posted menu.
