Code: The program is to ensure that children are served age-appropriate fluid milk.

Findings: During the inspection, it was determined that the program did not have the right type of milk. Program needs to have Vitamin A/D/1% milk onsite. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

Rule: 5180:2-13-14 Requirements for Field and Routine Trips

Code: The program is required to obtain written parental permission before leaving the premises and retain the forms for at least one year from the date of the trip. Routine trip permission forms must be updated annually.

Findings: In review of the program's records, it was determined that routine trip forms for the two children did not include the new destination for the Springdale Community Center Park.
