Code: The provider is required to maintain the required liability insurance or have a completed JFS 01933 "Liability Insurance Statement for Family Child Care Providers" on file for each child in care.

Findings: During the inspection, it was determined the provider did not have a completed JFS 01933 "Liability Insurance Statement for Family Child Care Providers" completed for each child in care and the form was not the most current version for other children. Correct the violation and submit proof of insurance with the program's corrective action plan to verify compliance with the requirement of the rule.
