Findings: During the inspection, it was determined that children were left unattended and not within sight or hearing. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Low Risk Non-Compliances

Domain: 02 Safe & Sanitary Environment

Rule: 5180:2-13-12 Safe Environment

Code: The program is required to store cleaning and sanitizing supplies in a place that is inaccessible to children. Cleaning agents, aerosol cans and chemical substances must be stored in their original container or clearly labeled. School-age children may use cleaning supplies and equipment with adult supervision.

Findings: During the inspection, cleaning and sanitizing equipment and supplies were not used or stored properly as noted in number 2 below:

1. Cosmetics were accessible to children in the [] area.
2. Disinfecting wipes were accessible to children in the diaper changing area.
3. Fish food was accessible to children in the [] area.
4. Hand lotion was accessible to children in the [] area.

Findings: During the inspection, it was determined the water temperature was 131 degrees Fahrenheit in the restroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
