Findings: During the inspection, a cleaning supplies were determined to be in reach. There was also rake/shovels in the outside area.

Findings: In review of the children's records, it was determined the program did not meet the requirements for caring for at least one child, indicated on the Children Records Review, with a condition that requires a JFS 01236 "Child Medical/Physical Care Plan." Reece did not have a JFS 1236 on file for his medical conditions. Reginald did not have a 1236 on file for Allergies or Eczema. Reginald's JFS 1236s on file were incomplete.

Medications were not on file for Reginald migraines.

Provide staff training. Submit the program's corrective action plan, which includes a copy of the completed JFS 01236, to the Department to verify compliance with the requirements of this rule.
