8. Small or lightweight pieces of shelving units are not securely anchored to the wall;
Staff member stepped over a barrier/gate while holding a child;
10. Chipping or peeling paint;
11. Emergency exits were blocked by the following furniture: [];
12. Cleaning products accessible under the kitchen sink.
13. Vitamins and pain medication accessible in the bathroom medicine cabinet.
