Findings: During the inspection, a potentially toxic substance was stored in a space used for child care during the program's hours of operation, but no children were present, as noted in number 5 below:

1. A lawn mower.
2. A weed trimmer.
3. Hedge trimmers.
4. A snow blower.
5. Other potentially hazardous substance, equipment or machinery: The Kitchen Refrigerator included medical medication accessible to children.
