Findings: During the inspection, it was determined that trash was improperly stored or not emptied daily, in that there were full trash bags in the kitchen which was accessible to the children. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Code: The program is required to have written documentation from a licensed physician if child is to be served something other than the required fluid milk.

Findings: During this inspection, it was observed that there was no documentation from a [licensed physician/parent] as required by the rule, when children between 12 and 24 months of age were served anything other than whole homogenized Vitamin D fortified fluid milk. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
