Findings: During the inspection, it was determined that unsanitary conditions, as noted in the following number(s) 4 below, were in the child restroom:

- 1. There was no liquid soap.
- 2. There was no toilet tissue.
- 3. There were no individually assigned towels or disposable towels.
- 4. The toilet cleaning brush was accessible to the children.
- 5. The plunger was accessible to the children.
- 6. The toilet was not flushed.
- 7. The trash was not emptied from the day before.
- 8. There was a strong urine odor.
- 9. Other.

The restroom(s) must be kept sanitary at all times. Submit the program's corrective action plan to verify compliance with the requirement of the rule.

Findings: During the inspection, it was determined that a pet at the program posed a threat to the safety or health of the children, in that other safety concerns included a cat was on the kitchen table while child ate breakfast as well as three cats did not have their inoculation record on file at program. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Findings: During the inspection, it was determined that the Ohio Communicable Disease Chart was not posted as required , as indicated in the number(s) 3 below:

1. In a location readily available to provider, child care staff members, employees, and residents;

2. The chart was not posted.

3. The posted chart was not the current version and the Child Care Manual Procedural Letter No. 159 was not posted next to the chart.

4. The posted chart was not displayed in the size available in the ODJFS forms central to be easily read.
