Findings: During the inspection, it was determined that the program's equipment was unsafe as noted in the following numbers 6 below:

1. A fan was unstable and could easily tip over;

- 2. A fan had openings a finger could enter;
- 3. Pipes from the heat pump felt hot to the touch;
- 4. The space heater felt hot to the touch;
- 5. The position of the space heater was a tripping hazard;
- 6. The air-conditioning unit was not enclosed and was accessible to children on the playground;
