Findings: In review of of the children's records, it was determined that completed medical statements were not on file, as required, for children listed on the JFS Children's Record Review For Child Care as indicated in number 1 and 2 below:

1. No medical was on file for at least one child
2. Medicals on file was not updated every 13 months
3. Medical were missing child's name and date of birth
4. Medical were missing the date of the medical examination
5. The date of the exam was more than 13 months prior to the date the form was signed
6. Medical were missing a statement that the child has been examined and is in suitable condition for participation in group care
7. Medical re missing the signature, business address and telephone number of the physician, physician's assistant(PA), advance practice nurse (APN) or certified nurse practitioner (CNP) who examined the child
8. Medical were missing a record of immunizations the child has had specifying month, day and year
9. Medical were missing a statement from the physician, PA, APN, or CNP that the child has been immunized or is in the process of being immunized against the diseases required by division 5104.014 of the Revised Code and found in appendix A to this rule
10. Medical were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
