Findings: Children in care shall be protected from any items and conditions which threaten their health, safety, and well being. During the inspection, it was determined that children were not protected from the following



item or condition which may threaten their health, safety, or well being as noted in the following number 3 below:

1. Open pull cords that are not closed loop;
2. Telephone cords;
3. Electrical/Extension cords attached to an object that would likely result in a severe injury if pulled;
4. Stacked chairs;
5. Employee(s) purse(s);
6. Diaper bags;
7. Television not securely anchored;
8. Small or lightweight pieces of shelving units are not securely anchored to the wall;
9. Staff member stepped over a barrier/gate while holding a child;
10. Chipping or peeling paint;
11. Emergency exits were blocked by the following furniture: [];
12. Other [].

In the childcare restroom beside the sink a hair dryer was hanging up on the wall with the cord hanging down that could cause harm if pulled down by the children in care. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Findings: During the inspection, it was determined that a pet at the program posed a threat to the safety or health of the children, in that proper licensing and/or inoculations not on file/ children exposed to pet's urine and/or feces/ other safety concerns in that the hallway up against the wall that leads to the child care playroom area was the cats litter box that was accessible to the children in care. Submit the program's corrective action plan to verify compliance with the requirements of this rule.
